

The West Bengal Panchayat (Members' Disqualification) Rules, 1994

CHAPTER I

Preliminary

- 1. Short tille and commencement.—(1) These rules may be called the West Bengal Panchayat (Members' Disqualification) Rules, 1994
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Definitions -(1) In these rules, unless the context otherwise requires,-
- the West Bengal Benchapet Act. 1973 (V. est Ben. Act XLI of 1973);

CHAPTER D

of information and procedure

- 3. Information of members to be duraished -(1) The Externent by the Leader, or by the member referred to in sub-section (4), under sub-section (3), of section 213A shall be furnished in Form 1.
- (2) The statement by the member referred to in sub-section (5) of section 213A under sub-section (5) of the said section, shall be furnished in Form 2.
- are $m{r}$ intermation.—The prescribed authority referred to in section 213A shall maintain in Form 3 a register based on the information furnished in Form 1 or in Form 2 as the case may be, under rule 3 in relation to the members of a Panchayat separately for each recognised political party and for each member not belonging to any recognized political party.
- 5. Stalersace by polition.—Every polition reserved to in sub-section (7) of section 213A and the annexure thereto, if any, shall be signed by the patitioner and weithed in the manner laid stown in the Gode of Civil Procedure, 1908 (5 of 1908) for the verification of pleadings.
- by incipeutoner and vertication of presenting any incidental be followed by the prescribed authority referred to in sub-section [1], for determining any quastionard for the purpose of making any enquiry under sub-section [9], of section 213A shall be, so far as may be, the same as the procedure additionally the Committee of Privileges of the West Bengal Legislative Assembly.

 [2] The prescribed authority as aforesaid shall not come to any finding under clause (b) of sub-section (11) of section 213A in respect
- of a member without affording a reasonable opportunity to such member to represent his case and to be heard in person.
- [3] Swary decision decising a member to be disqualified under the Act, shall be reported by the prescribed authority as aforesaid to the concerned Panchayat the authority to whom appeal lies against the decision, the District Panchayat Election Officer, the State Election Commissioner and the State Government.
